1. Introduction: National Development Programme (NDP) implemented the project titled "Strengthen Civil Society and Public Institutions to Address Combating Gender-Based Violence" with the purpose to enhance the capacity of civil society and public institutions to address violence against women in a public and private domain in Rajshahi. The project addressed gender-based violence engaging men and boys as a strategy. The project has mobilized youth, men, women, and adolescents as change agents to facilitate the gender equality norms and values which ultimately resulted to reduce gender-based violence acts on women. The project aimed to reduce the incidences of violence against women by creating opportunities for young women in a leadership position. Several capacities building training was provided to the government officials and related stakeholders to increase their proactive role for gender justices, violence prevention and change in attitudes and behaviour perpetuating gender based violence.

2. Project description

Goal: To enhance the capacity of civil society and public institutions to address violence against women in public and private domain.

Objective:

- 1. To promote gender equality and the protection of women's human rights by reducing violence women & girls in targeted area.
- 2. Strengthening of public institutions to ensure responsiveness towards gender concerns including VAWG.

Outcomes:

Output 1.1: Men and boys are aware of women's right to safety, security and bodily integrity at home, community and workplace.

Output 1.2: Women are confident and equipped with leadership to prevent GBV.

Output 1.3: Civil society has capacity to monitor implementation of legislation, identify institutional constraints and develop strategies to prevent GBV.

Output 2.1: Targeted citizens are capable of using social accountability tools to hold public institutions accountable on GBV issues.

Output 2.2: Targeted LGIs and public service providers have capacity to respond appropriately to victims of GBV.

Major Activities:

- 1) Form and strengthening of groups through meeting, orientation on social issues.
- 2) Social support group for participating in action against GBV.
- 3) Strengthen coordination among VAW prevention committee, civil society, administration, public institutions and LGIs.

3. Major Accomplishments/Achievements of the project

This portion will include quantitative and qualitative achievements of the project. Overall changes, and impact as per outcome and output indicators will be described here.

- Child marriages have been stopped -151 (through local UP members consisting of male group, women's group, adolescent group, youth group, members of Union and Upazila Social Support Committee and notable personalities of the area).
- Family Dispute Resolution 189 (through 42 arbitrations and Through 138 counselling.
- Marriage without dowry: 26
- Participated in training from Upazila Youth Development Department, Department of Women's Affairs and Department of Agriculture (sewing training, cow fattening, seed conservation and earthworm manure production, food processing and preservation, fertilizers and pesticides): 123 people also participated in 159 trainings from various NGOs. .
- Assistance to get Social safetinet from Union Parishad: 112 people(VGD, VGF, Old age Allowance and widow allowance)





- The members of that group believe that violence against women is a criminal offense
- The bias of the men and youths of that group towards women has changed Women's participation in rural arbitration has increased.
- The number of service recipients has increased according to the type of government service provider.
- Acceptance has increased in the area of women team members other members including members of women group are playing a leading role in resolving family disputes. Women members and other members are taking appropriate steps to prevent child marriage.
- Awareness has increased in the area to prevent and combat gender-based violence
- The tendency of women to become self-reliant has increased Women's confidence has increased.

4. Lesson learned from the project

Lessons Learned:

- Effective interpersonal communication with the local government, leaders, and community people, the project activity is run smoothly.
- Have good relation with targeted beneficiaries, UP/Upazila bodies, Elite persons, Imam, Kazi to accomplish our targeted task properly.
- Social and family advancement is possible when women contribute to income-generating activities.
- The marginalized women of the village will reveal their secret information only when they think that you are by their side.
- It is not possible to change society alone.
- Support Your Team: Delegate tasks appropriately and enforce realistic deadlines.
- Give Praise Often: Let your team know when they have done something well
- Applying fluent language in professional conduct
- To exchange aptitude with innovation and creative thinking
- The present intellect understands the situation by adopting different strategies
- Maintaining contact with service providers at the local level to meet project goals and objectives.
- To make the groups aware by court yard meeting and training
- Stablishing accountability by ensuring transparency by avoiding bias at local level
- There is no alternative to meeting seminar orientation in establishing more women
- Rural women do not want to disclose the issue of domestic violence as it is a private matter. The members of the women's team have kept the contact numbers of the officers protecting women from violence and they are informing the NDP staff, member chairman and others about any incident.
- Community level women leaders are going to the union council to speak for their rights individually and collectively are realizing their demands.
- Maintaining contact with service providers at the local level to meet project goals and objective beneficiaries with equal financial capacity.
- Women community leaders are contributing to the local arbitration by providing feedback.
- Conducting group meetings of group presidents, reading resolutions, building leadership skills and recording.
- To establish and coordinate good relations between the service providers and notable persons and group members.
- Involving group members in the selection process to survivor supports distribution is very effective. Because it ensures proper use of supports. The survivor could not misuse the asset.
- During this pandemic situation, we have learned that we need to develop community-based proactive, self-motivated, and pro-people, leaders who can take responsibility in an emergency.
- Social accountability tools related activities are easy when social support committees are able to internalize the objective of the tools.
- People will get better service and GBV will reduce by strengthening local Salish system.
- Women will be able to earn money that can empower them as a decision maker within the family and society through the skill development training





Best Practices:

- Taking a clear concept about the subject of the meeting
- Communicate with group members the day before the meeting
- The group meeting started and ended on time
- Conducting party meetings of party presidents, reading resolutions, building leadership skills and recording.
- Committed to gender sensitive work and team building
- Recording of diaries and registers and keeping of reports
- Immediate decision making to prevent child marriage and violence against women
- Always be aware of your responsibilities and duties and maintain professionalism
- To establish and coordinate good relations between the service providers and notable persons and party members.
- Be Vulnerable, Stay Committed, Seek Clarity, and Create Cultural Cohesiveness, Focus Team Effort. Hold Regular Meetings.

5. Challenge and overcome:

Challenge:

- Local elected bodies can play a vital role to stop child marriage, but sometimes they do not show interest in it. Because they think it may hamper their popularity.
- Women did not disclose domestic violence related incidents due to fear of divorce. According to rural
 women, case filing against domestic violence is one of the major areas which can be the cause of divorce.
 Community people are liable to women for divorce and insult them. So women feel fear for case filing
 against gender based violence victims by breaking social custom.
- Adolescent girls are developing relationship with others through social media and got married in another location before the legal age of marriage without consent of parents.
- Availing legal services are not possible due to lack of proper documents when marriages were held without registration.
- Due to corona outbreak, SPIs are busy in law enforcing so GBV issues became less prioritized.
- Changes of Officers of Charghat Upazila. New officer has less knowledge about the project CGBV.
- During pandemic situation we cannot provide support as per their expectations.
- Insufficient cooperation of Union Parishad.
- Timely presence of Beneficiaries. Participants and UP Chairman, members, Govt. Officials in a different meeting.
- Ensure the presence of men and boys at the meeting
- Reducing violence against women in society
- The newly appointed staff did not receive any training like SAT, Fact Findings, Case management and need to basic training of the project.
- The budget is too poor to organize the community-level meeting, workshop, seminar, and training.
- In some cases, group members want to get the benefit of receiving cash.
- Did not achieve the project goal in the pandemic situation
- High masculine mentality of community people
- Beneficiaries randomly called Hotline numbers 109, 333, 999 for stopped child marriage. But the hotline numbers don't respond to their call. That's why we failed to achieve the goals of the project design. We worked in the field in pandemic situations. But we did not get any kind of precaution from the project.
- It is not possible to collect the information and implement activities in the field due to COVID-19 situation and lockdown.
- Continue to communicate and coordinate with beneficiaries at the community level by coping with the 3rd wave of Covid-19.
- The newly elected people's (UP) representatives are not aware of the activities of the project.
- The scope of service delivery is limited compared to the number of beneficiaries.
- Political and Influential, Individual Class Influence, and Prejudicial Attitude towards Women.





• Patriarchal attitude, social customs and religious bigotry.

Overcome:

- To mitigate the challenges, the team dedicated to achieving the target and time to time communicate and motivate the up bodies, members, and others. The team also works on proper planning and extra hard work.
- Project staff uses personal safety measures.
- They are meant to be discussed in detail at group meetings
- Setting meeting time for organize community level meetings with men & boys by consultation with them
- Communicate with the project beneficiaries and other stakeholders to collect information, relation build up.
- Collect information for field by using technology.
- Contact with beneficiaries by phone. It's an emergency, we communicate physically.
- Being a hotline number for the whole country leads to numerous complaints. It is not possible to take action for so many complaints at once.
- The activity has been implemented in compliance with the safety net.
- Due to the restrictions of Covid-19, limited contact was made with the body at the field level, but through continuous communication with the group leaders through mobile phones, information was collected and necessary advice was given.

Aktaree Begum welcomes speech and objective sharing of Public Hearing. Chief Guest Advocate Meheruneesa (OCC) and SI Md. A. Majed sharing their services. President of Union Social Support Committee Md. Shahin Reza (Yusufpur) and Md. Azizur Rahman (Salua) were also present as Special Guests, Women, Youth group member and NDP Staff, project facilitators Md. Abdul Hannan, Mst. Mousumi Khatun, Mst. Tanzila Aktar and Mst. 128 (Men-09, Women-119) participants were attend in this event.

Khurshida Bahar, Hon'ble Chairman of Shalua Union Parishad Md. Ziaul Haque Masum was present as the Chief Guest and Upazila Education Officer Md. Joynal Abedin was present as the Special Guest. Also, present Shalua High School Headmaster Md. Babul Islam, Upazila Social Support Committee President Md. Saiful Islam Badshah and members of Union Social Support Committee and NDP CGBV Project Officer Mst. Rashida Parvin, Accounts Officer Md. e.School Campaign will be held at Shahapur and Chakkapasia on 09 February, 2022 at the beginning of the meeting, the project facilitator greeted everyone present and inquired. He congratulated all the participants for attending the meeting. He called on Project Officer Mst. Rashida Parvin to conduct the meeting. The meeting was presided over by Mst. Rashida Parvin. At the outset, the Field Facilitator talked about what child marriage is its causes, ways to prevent it, barriers to child marriage prevention, violence against women, and so on. What is child marriage: - The age limit prescribed by the law, that is, 18 years for girls and 18 years for boys under the age of 21 is called child marriage. Reasons for child marriage: Social and cultural practices, Religious bigotry, Neglect of daughter, Social insecurity, Lack of proper enforcement of law. The reluctance of the common man towards the law. Lack of awareness. Lack of database of girls at risk of child marriage etc. Ways to prevent child marriage: Seeing boys and girls equally and giving them equal opportunities. Not to give marriage to boys and girls before immaturity, Respect the law of the land. Encourage children to use mobile and internet safely. Keep an eye on children's movements. To educate boys as well as girls in higher education. The girl says not to neglect them etc. Obstacles to prevent child marriage: Negative attitude towards daughter children. Indifference of law enforcement organizations. There is no provision for punishment in the aftermath of child marriage. Manipulation of birth registration certificate. Not respecting the law. Own social system of small and backward people etc. Misuse of mobile and internet. Women abuse Violence against women refers to any form of physical, mental, social or economic oppression of women. Violence against women is a situation in which women are forcibly deprived of their personal and social life and face physical, sexual and emotional harm. Decision: Students will not take child marriage by taking oath. They will stop their friends from having sex. Women will resist torture.



f.Interface Meeting arranged by NDP at Yusufpur and Salua union of Charghat Upazila, Rajshahi to give clear idea among Community people about union Parished of government sector, build an effective relationship between service provider institutions and Community people will interest to take service from those institutions in future Union Nari Nirjaton Nirodh committee member are active and reduce child marriage and gender based violence by the help of Union Parished service provider institutions. In this event Allhaz Saiful Alam Ratan-and Ziaul haque Masum Chairman of Yusufpur union was the chief guest who presided the event.A number of 118 persons including (male 46, female72} Teachers, community people, Social Support Committee members, project staffs have participated at the Interface meeting. The event has held on November 03, 2021and November 14, 2021 from 10.00 AM to 1:30 PM. The event started with introduction and taking seat of all guests. This event moderated by Mst. Rashida Parvin (Project Officer).Gave the opening speech for objectives of this meeting. Mst. Sharmin

Rashida Parvin (Project Officer) was sharing before arrange meeting about FGD in community score card and self-evaluation union parished score card. At the end of the meeting UP Member and Community people both are prepared an Action Plan and committed Union Nari Nirjaton Nirodh committee member are active and continuing meeting regularly. Community Score Card activities are given below:Input tracking (UP), FGD (Community), Self Evaluations, Interface Meeting, Action Plan displayed on PVC board at UP Premises. A number of 118 persons including (male 46, female72) Teachers, community people, Social Support Committee members, project staffs have participated at the Interface meeting



g.On 14 th January, 2021 we have arranged mobilization on stop rape on Kolabagan school student's ensure justice at Chourasta Mor, Charghat on 11.00 am 11.45 am where principle of MA Hadi College, Charghat, Police representatives, School & college teacher, Journalist, youth, adolescent, women & men group member, student, upazila social support committee member and local elites also participated. All are raise voice to act against rape on women & children.



h.3 days long TOT on Gender and Human Rights for Advanced Youth and Adolescent Training will be held at 20-22 December, 2020 in Salua Union Parished Hallroom, Salua, Charghat, and Rajshahi. This session are facilitating CGBV-NDP Project Staff. The main Contents are discuss there is Inauguration the training, Introducing to each other, Expectation, Goals and objective of the training, Experience analysis, Concept of Rights and Human Rights, Gender Relationships analysis, International and National Charter Policies and Laws, Bangladesh has law to prevent violence against women. After complete the session participant's will be able and explain about gender and Human Rights and Prepare a work plan and committed to vital role prevent early marriage and any incidents of violence against women.

Activating different committee related to prevent violence against women at UP and Upazila level can revitalize government officials and related stakeholders to increase their pro activeness and attitude towards reduce gender based violence.
