2. Background

At the end of 1988, there was a devastating flood that engulfed large areas of land and caused huge damage of lives, livelihoods and properties in Bangladesh. Sirajgonj district was particularly vulnerable at that time due to its geographical location which is situated on the bank of the river Jamuna. A number of national and international NGOs came forward to provide support to the flood victims. A group of dedicated local youths, including Md. Alauddin Khan, the Executive Director at present, voluntarily involved themselves with those NGOs in emergency response and rehabilitation operations. Being very close to the harsh realities of the poor people of the area, they realised that merely carrying out relief and rehabilitation operations was not enough. They have decided that long term solutions and implement long term programs for sustainable development. These programs would require the effective participation of the entire community in planning, management and monitoring processes and be backed up with needs-based credit supports. Future programs would also need to build the capacity of individuals and communities through technically viable activities in order for true development to take place. It encourages them to form an organization independently and accordingly on the 1st January 1992 "National Development Programme (NDP)" emerges as an NGO.

NDP is a non-governmental organization. By virtue of constitution, it is a non-profit, nonpolitical voluntary development organization. The key objective of NDP is *to strengthen capacity of the targeted participants (beneficiaries) and create opportunities to bring them into the mainstream of development process*. Now NDP has been implementing 31 different programme/projects and its operational area covers seventeen districts under Rajshahi, Rangpur and Dhaka division in the northern region of Bangladesh. NDP always places an emphasis on human rights, good governance and gender equality, transparency and accountability. Through its dedicated efforts for long twenty-seven years, NDP has become the symbol of hope for the poor people as it serves for them and would like to development works for long time as it is needed.

As we know that risks are the integral part of development process and even if we don't realize it. Risk management is one of the key stands of NDP as we are implementing # program and projects. NDP realized that instead of sporadic initiatives for risk management they should have a standard risk management plan so that they could move with proper initiatives to reduce risks at different level bas on their risk assessment, prediction and mitigation plan. Considering this reality NDP has developed risk management plan to save resources including cash, kind and human and also to develop organizational credibility.

3. Definition Risk Management

Risk management is the process of identifying, assessing, mitigating, and controlling threats to an organization. These threats could stem from financial uncertainty, legal liabilities, management, accidents, or natural disasters. Because of the growing information security-related threats, companies' risk management programs are under intense scrutiny from industry and governing bodies. Protecting digital assets like protected health information, cardholder data, personally identifiable information, intellectual property, or financial statements is a top priority.

4. Objectives of Risk Management Plan

Objectives of the risk management plan are to protect the organization, its assets and staffs from unexpected situation that are defined as risk. By identifying, analyzing and ranking the risks a way out is developed to mitigate the risks. Main Objectives of the risk management are following:

- To detect and identify potential risks of Organization, programs and projects efficiently considering Internal and External actors, factors and diverse situation.
- To analyze the risks from different perspectives and also identify causes and effects of risks considering short and long term impact
- To prepare and develop a plan for controlling measures of risks which will protect resources and goodwill of organization.
- To develop a control mechanism for monitoring and follow-up risk mitigation activities and document of organizational learning as memories.

5. Principles of Risk Management

Risk management standards have been developed by several organizations, including the National Institute of Standards and Technology and the ISO. These standards are designed to help organizations to identify specific threats, assess unique vulnerabilities to determine their risk, identify ways to reduce these risks and then implement risk reduction efforts according to organizational strategy. The ISO recommended the following target areas, or principles, should be part of the overall risk management process:

- The process should create value for the organization.
- It should be an integral part of the overall organizational process.
- It should factor into the company's overall decision-making process.
- It must explicitly address any uncertainty.
- It should be systematic and structured.
- It should be based on the best available information.
- It should be tailored to the project.
- It must take into account human factors, including potential errors.

- It should be transparent and all-inclusive.
- It should be adaptable to change.
- It should be continuously monitored and improved upon.

6. Risk Management Committee

A risk management committee has been formed in the initial stage of developing the risk management plan. The committee has formed with seven members from higher management of NDP where Executive Director has chaired as convener and others six are members of the committee. The committee will be responsible for identifying new risk for the organization and plan to mitigate those risks. The committee will also help to include the mitigation plan to other related policies and develop ToR as per department of NDP. The committee would review the Risks Management plan annually.
